Bids must be delivered to procurement and Disposal Unit at or before 16th August, 2018 at 9:00 representatives. Late bids shall be rejected. Bids shall be opened in the presence of the bidders

or their representatives who choose to attend at the District boardroom on 15th October 2018 at 09:00 am.
